HIGHWAY SAFETY COMMITTEE

Meeting Minutes December 9, 2019

Location: Police Department- Bradford L. Cross Community Room

Members Present: Police Chief Denise Roy, Public Works Director Kyle Fox, Deputy Police Chief Brian Levesque, Town Councilor Finlay Rothhaus, Community Development Director Tim Thompson, Public Works Deputy Director/Town Engineer Dawn Tuomala, and Resident Glenn Wallace, Esquire.

1. Call to Order: Chief Roy called the meeting to order at approximately 1:10 p.m.

2. Approval of Minutes: Corrections were made to the spellings of Glenn Wallace's name and that of C.R. Willeke. Minutes were approved unanimously by the committee.

3. Old Business:

- Pond View Drive/Daniel Webster Highway Intersection. <u>See Attachment 1.</u> The committee agreed to table any related issues indefinitely to be addressed at the time a town center or bike/pedestrian plan committee convenes.
- Route 3 Corridor Study. Kyle Fox provided a brief update communications with Jay Minkarah, Executive Director of Nashua Regional Planning Commission (NRPC), as well as a meeting with the Governor and other area representatives attended by Town Manager Eileen Cabanel and Kyle Fox at which time issues related to the Route 3 corridor study were addressed. The committee agreed to table the issue to be addressed at a later time, if necessary, as the committee's intention that the issue is a priority has already been expressed during past committee discussions.

4. New Business:

• Hadley Road parking issues. See Attachment 2. The committee was joined by Resident, Dawn Cote, of Hadley Road who expressed concerns related to parking during school hours. Dawn Tuomala provided an update to the ongoing parking issues, primarily during the days and times when school is in session, and the inability of emergency and maintenance vehicles to access the road due to students parking their vehicles along the road. The committee agreed to

have Chief Roy bring the issue before the Town Council and request that Hadley Road parking prohibitions under Town Ordinance 183-36 be expanded to include restrictions on the entirety of Hadley Road during school days from 7:00 a.m. to 4:00 p.m., with appropriate signage to be erected.

- Amherst Road/Turkey Hill Road intersection traffic/back up. The committee discussed erecting a stop sign on Amherst Road and/or reconfiguring the roadway so as to address the issue of traffic and back up when the post is not manned by the police department's traffic control personnel (Monday Friday 7:00 a.m. 9:00 a.m.). It has been determined that, due to various factors, reconfiguring the road way (additional lane, rotary, retaining wall, etc.) is not possible. A traffic count/study will be conducted and, thereafter, it will be determined if further action is warranted.
- Church Street. <u>See Attachment 3.</u> The issue of a "No Right Turn" being erected on Daniel Webster Highway southbound was discussed. The closing of Church Street entirely has been discussed in the past and was rejected. It was decided by the committee that, at the time the town addresses the issue of incorporating sidewalks, the issue of Church Street will also need to be addressed for various reasons. Chief Roy will bring the issue before the Town Council.
- Camp Sargent Road/Access to Outlet Mall. The issue of the potential need for a sign directing
 traffic away from Camp Sargent Road to the outlet mall was discussed. Deputy Chief
 Levesque advised that a traffic count was done and there is no indication there are traffic
 issues along Camp Sargent Road related to outlet mall traffic which would necessitate such a
 sign.
- Turkey Hill/Baboosic Lake Road intersection. Dawn Tuomala presented various concepts for reconfiguring the area, the cost of which has already been included in this year's budget. The best option will be determined and the construction and implementation will then be put out to bid.
- Hilton Drive/Daniel Webster Highway intersection. The Department of Public Works is
 working with NPDC and DOT in order to have a study conducted. It was decided that the
 study previously conducted in or around 2004 will be provided to Jay Minkarah of NRPC and
 the issue of a possible "Do Not Block The Box" signage would also be addressed.
- Committee Membership. The committee acknowledged the passing of member, Bill Godfrey, and expressed appreciation for his service. Dan Bantham has agreed to accept an appointment to the committee for a term of 1 year. Glenn Wallace and Paul Konieczka will be re-appointed to the committee for terms of 3 and 2 years, respectively. The appointment and reappointments were approved unanimously by the committee.
- 5. Adjournment: The meeting adjourned at 2:20 p.m.

She was the one that had the concerns previously at the DW Drive and DWH intersection. We had previously changed a yield sign to a stop sign and added stripping and an object marker.

She now has additional concerns that at the Pond View Drive and DWH Intersection (across from King Kone) they can't make the left hand turn and have to wait 10 minutes to get out. It's getting worst and happening more and more. She was asking for a yellow light or turning lane etc.

Under the MUTCD Section 4B.02 Basis of Installation or Removal of Traffic Control Signals the determination would be made after an engineering study of roadway traffic and other conditions such as pedestrians, bicyclists etc. This study has not been done at this time.

Possible recommendation is to have the intersection analyzed when a sidewalk and or a bike path (per the Town Center Committee plans) is going to be installed. At that time we could also put in funding to change the intersection in this area.

CHAPTER 4B. TRAFFIC CONTROL SIGNALS—GENERAL

Section 4B.01 General

Support:

- Words such as pedestrians and bicyclists are used redundantly in selected Sections of Part 4 to encourage sensitivity to these elements of "traffic."
- Standards for traffic control signals are important because traffic control signals need to attract the attention of a variety of road users, including those who are older, those with impaired vision, as well as those who are fatigued or distracted, or who are not expecting to encounter a signal at a particular location.

Section 4B.02 Basis of Installation or Removal of Traffic Control Signals

Guidance:

The selection and use of traffic control signals should be based on an engineering study of roadway, traffic, and other conditions.

Support:

A careful analysis of traffic operations, pedestrian and bicyclist needs, and other factors at a large number of signalized and unsignalized locations, coupled with engineering judgment, has provided a series of signal warrants, described in Chapter 4C, that define the minimum conditions under which installing traffic control signals might be justified.

Guidance:

- OB Engineering judgment should be applied in the review of operating traffic control signals to determine whether the type of installation and the timing program meet the current requirements of all forms of traffic.
- If changes in traffic patterns eliminate the need for a traffic control signal, consideration should be given to removing it and replacing it with appropriate alternative traffic control devices, if any are needed.
- Of If the engineering study indicates that the traffic control signal is no longer justified, and a decision is made to remove the signal, removal should be accomplished using the following steps:
 - A Determine the appropriate traffic control to be used after removal of the signal.
 - B. Remove any sight-distance restrictions as necessary.

C. Inform the public of the removal study.

- D. Flash or cover the signal heads for a minimum of 90 days, and install the appropriate stop control or other traffic control devices.
- E. Remove the signal if the engineering data collected during the removal study period confirms that the signal is no longer needed.

Option:

- Because Items C, D, and E in Paragraph 5 are not relevant when a temporary traffic control signal (see Section 4D.32) is removed, a temporary traffic control signal may be removed immediately after Items A and B are completed.
- Instead of total removal of a traffic control signal, the poles, controller cabinet, and cables may remain in place after removal of the signal heads for continued analysis.

Section 4B.03 Advantages and Disadvantages of Traffic Control Signals


Support:

- When properly used, traffic control signals are valuable devices for the control of vehicular and pedestrian traffic. They assign the right-of-way to the various traffic movements and thereby profoundly influence traffic flow.
- Traffic control signals that are properly designed, located, operated, and maintained will have one or more of the following advantages:
 - A. They provide for the orderly movement of traffic.
 - B. They increase the traffic-handling capacity of the intersection if:
 - 1. Proper physical layouts and control measures are used, and
 - The signal operational parameters are reviewed and updated (if needed) on a regular basis (as
 engineering judgment determines that significant traffic flow and/or land use changes have occurred)
 to maximize the ability of the traffic control signal to satisfy current traffic demands.
 - C. They reduce the frequency and severity of certain types of crashes, especially right-angle collisions.
 - D. They are coordinated to provide for continuous or nearly continuous movement of traffic at a definite speed along a given route under favorable conditions.
 - E. They are used to interrupt heavy traffic at intervals to permit other traffic, vehicular or pedestrian, to cross.

Hi.

Instead of bringing this issue to the full highway committee I only spoke with the police afterwards. The reason being if we put restrictions on the north side of Hadley this will prohibit the 2 residences on the street from parking other than in their driveway. If they have any type of gathering at their homes they don't have any place for their guests to park.

The current code only allows for Prohibiting Parking at all times. We would have to create another code in order to do something different. We can do that but let's try the way the police are suggesting first.

Presently the Codes prohibit All-night parking on the streets at night between Nov. 15th to April 15th between the hours of 11 PM to 6 AM.

There is also a code 183-18 – Impeding Snow Removal. This is the code that the police will use. So if you know that you are going to be doing snow cleanup in the area a day or two later than the storm let the police know and if there are cars parked there they will contact the school and the owners and then have them removed.

I know that this is an inconvenience for you but that is all they are willing to do at this point. They feel that people do have the right to park there so they aren't willing to tell the students to park on O'Gara instead. If this doesn't work then we can go before the Committee and come up with another solution. We need to keep in mind that anything more and it will impact the homeowners. Right now they haven't been complaining about the students cars there so they seem to be co-existing.

Maybe the school might help us if we were to talk to them about the issues directly?

Let me know what more I can do. Dawn

After discussing your concerns with the Chief, she suggested that I not involve myself any further and to instead have Chris Spillane be our PD representative. As my son currently goes to school at MHS, my involvement could be interpreted as inappropriate, which the PD doesn't need. Chris has been made aware of your concerns with regard to Hadley Rd (i.e. emergency vehicle access) and we're all in agreement that things need to change. My thoughts were to perhaps request a meeting with Rich Zampieri to discuss opening up all available parking to the students. I figured this would be a good place to start because if we're going to put restrictions on Hadley Rd, let's get ahead of the "we have nowhere else to park" excuse. If the school makes the numerous empty parking spots available, see attached photographs, then no one has any reason to park on Hadley Rd. I talked to Derek Hart (as well as Murray during his tenure) who has already been down this road with Rich and was warned that this is a very sensitive subject. I was also made aware that Rich will have many reasons for their current parking situation (i.e. all those available spaces are being used by come and go students, that they could just take the bus, all permits have been issued, etc.). All of these reasons to be honest don't make any sense to anyone I've discussed this with. The above pictured lots are 90% vacant the entire day and have been so for years. So I'm not really sure what the hang-up is at that end, but I think by making available parking "available", the school can help us clean-up the Hadley Rd situation. Regardless and in fairness to Rich, I think we need to start with him first and proceed from there. If you have any further suggestions or questions, please don't hesitate to reach out. Otherwise, I'll let Chris handle it with your





Chapter 183. Vehicles and Traffic

Article III. Parking Restrictions

§ 183-15. Definitions.

As used in this article, the following terms shall have the meanings indicated:

PUBLIC STREETS AND HIGHWAYS

All ways serviced by public snow removal equipment and all streets accepted by the Town.

§ 183-16. Removal of vehicles.

In addition to all other penalties, fines or violations imposed under this article, all vehicles found in violation of this article may be removed by order of the Police Department. Costs of such removal and of subsequent storage of removed vehicles shall be paid by the vehicle owners prior to release of such vehicles to said owners.

§ 183-17. All-night parking in winter.

No vehicle or trailer shall be parked on any public street or highway between the hours of 11:00 p.m. and 6:00 a.m. from November 15 to April 15.

§ 183-18. Impeding snow removal.

No vehicle or trailer shall be parked on any public street or highway between November 15 and April 15 in such a manner as to impede snow removal.

§ 183-19. Parking prohibited at all times.

- A. No person shall park a vehicle or trailer at any time upon any of the streets or parts of streets thereof described in Schedule IX, Parking Prohibited at All Times (§ 183-36), attached to and made a part of this chapter.
- B. Except when necessary to avoid conflict with other traffic, or in compliance with law or the directions of a police officer or official traffic control device, no person, except a person driving an emergency vehicle, shall:
 - (1) Stop, stand or park a vehicle:

- (a) On the roadway side of any vehicle stopped or parked at the edge or curb of a street.
- (b) On a sidewalk.
- (c) Within an intersection.
- (d) On a crosswalk.
- (e) Between a safety zone and the adjacent curb or within 30 feet of points on the curb immediately opposite the ends of a safety zone.
- (f) Alongside or opposite any street excavation or obstruction when stopping, standing or parking would obstruct traffic.
- (g) Upon any bridge or other elevated structure upon a way or within a highway tunnel.
- (h) On any railroad tracks.
- (i) At any place where official signs prohibit stopping.
- (j) In any parking place, whether on public or private property, specially designated for the physically handicapped by means of a sign stating that the space is reserved for the physically handicapped or displaying the wheelchair symbol as defined in RSA 275-C:9, 1(a), unless that person has special number plates, a number plate decal or a tag or card issued pursuant to RSA 261:86, 261:87 or 261:88.
- (k) On any controlled access highway.
- (I) In the area between roadways of a divided highway, including crossovers.
- (2) Stand or park a vehicle, whether occupied or not, except momentarily to pick up or discharge a passenger or passengers:
 - (a) In front of a public or private driveway.
 - (b) Within 15 feet of a fire hydrant.
 - (c) Within 20 feet of a crosswalk at an intersection.
 - (d) Within 30 feet upon the approach to any flashing signal, stop sign or traffic control signal located at the side of a roadway.
 - (e) Within 20 feet of the driveway entrance to any fire station, and on the side of a street opposite the entrance to any fire station within 75 feet of said entrance when properly posted by a sign.
 - (f) At any place where official signs prohibit standing.

§ 183-20. Overnight parking.

A. No person shall park any of the following defined vehicles on any street or highway in the Town of Merrimack for a period of time longer than 30 minutes between the hours of 11:00 p.m. and 5:00 a.m., local time, of any day, except persons on

emergency calls:

- (1) Camper: A separate vehicle designed for human habitation and which can be attached or detached from a pickup truck.
- (2) Motor home: A self-contained vehicle, designed for human habitation, with its own motive power and with a passageway from the body of the home to the driver's and front passenger's seat.
- (3) Trailer: A vehicle without motive power, designed for carrying persons or property on its own structure and to be drawn by a vehicle with motive power. The term "trailer" shall include trailer coach, semitrailer, travel trailer or utility trailer.
- (4) Motor truck: Any motor vehicle with an empty weight of more than 5,000 pounds.
- B. Notwithstanding the above provisions, the Chief of Police may grant, at his discretion, if traffic and safety considerations permit, permission to park a vehicle on any street or highway for a period of time not to exceed 48 hours.

§ 183-21. Violations and penalties.

Any person, firm or corporation violating the provisions of this article shall, for each violation and upon conviction thereof, pay a fine of not more than \$500.

§ 183-22. Registered owners.

Any motor vehicle parked or left in violation of any part of this article shall be presumed to have been left by the registered owner thereof. Such presumption shall be prima facie evidence of responsibility for such violation.

Chapter 183. Vehicles and Traffic

Article V. Schedules

§ 183-36. Schedule IX: Parking prohibited at all times.

In accordance with the provisions of § 183-19, no person shall park a vehicle at any time upon any of the following described streets or parts of streets:


