#### **Old Business:**

- A. Master Plan—The consensus of the sub-committee is to submit a draft of the Master Plan to the MCC at its September 19 meeting. The sub-committee will meet on August 30, 2022, for the purpose of laying out the organization of the plan and the details that will be included. To ensure that the presentation of the plan will be included in the MCC's September 19 meeting, the draft will be submitted to the MCC by September 15.
