MERRIMACK CONSERVATION COMMISSION TUESDAY, MARCH 29, 2022 – 10:00 A.M. MEETING MINUTES ONSITE AT SKLAR WATERFRONT PARK

A meeting of the Merrimack Conservation Commission was held on Tuesday, March 29, 2022, at 10:00 a.m. at Sklar Waterfront Park.

• Review the status of the existing public boat ramp and discuss options

Discussion with Garret Graaskamp regarding whether NH Fish & Game (NH F&G) would consider providing financial assistance towards a boat ramp at the location adjacent to the Sklar Waterfront Park.

Town Manager Paul Micali clarified that the boat ramp is on Town property. Garret Graaskamp stated he does not see this site as a priority as there are too many issues, mainly limited access due to turn limits and the low, narrow bridge which is the only way onto the property. It was estimated that it's unlikely that anything bigger than a 16' boat would be able to get under the bridge.

NH F&G uses money funded by motor boat licenses to build boat ramps, so if they were to fund a boat ramp, they want to make sure that ramp is used by those with motor boats.

If the Town of Merrimack would fix access, NH F&G may be interested in contributing some funding.

NH F&G has about \$1M a year to contribute to boat ramps - \$450k from federal monies, and the balance is from motor boat license fees (\$5/boat). Once Conservation Commission takes money from Fish & Game for a boating ramp, we incur legal obligations that limit our control of that ramp and access to it.

If the rail project goes through, the new owner of the railroad may make the bridge taller and wider. The project is not guaranteed to go through Merrimack, in which case, the bridge will remain as is.

Question to Garret Graaskamp on whether he is aware of the Mobi Boat Ramps. He is aware of something similar that is used for kayaks and canoes, but does not believe it would be a viable ramp for this location.
