- The Thermostat locations shall be: Dayroom, Training Room, Captain's Office, Radio/Pole Room
- From the time the purchase order is signed, the winning contractor shall have 120 days to complete the entire project.
- Once work has commenced, it shall be completed in thirty (30) days.
- The bid date has been revised to **2:00PM on Monday, June 15, 2015**.
