Legislative Updates from State Representatives

Councilor N. Murphy shared that on the 9th, Rep Healey sponsored HB1191 relative to the establishment of an exemption to the meals and room tax for participants in the restaurant voucher program. Rep Rung, Rep Murphy, and Councilor Healey testified in support, and they are hopeful this gets support in the Senate so it can get over to the House. She also shared that SB511, sponsored by Senator Chandley, is relative to road salt and well contamination with MVD. It specifies salt application requirements and procedures for the DOT as salt contamination has caused substantial harm to the wells to the point where MVD has had to shut down Well #3 and replace it with Well #9 at a cost of about \$2 million. This bill is making specific requirements for how the roads in this area are treated to prevent this issue from worsening as it has caused an impact to the community and health of Merrimack residents. The next bill, SB466, again filed by Sen Senator Chandley, relates to citizen requests and concerns about the Everett Turnpike widening project and the DOTs refusal to install sound barriers around resident's homes. This bill proposes an option to making sound barriers available to impacted residents by allowing the DOT to erect them upon the request of municipalities. This bill would create two programs for the construction of noise barriers: one using federal highway money for 70% of the cost of the barrier, and the other using a state matching grant program using general fund money for 70% of the cost of the barrier. Any municipality requesting a sound barrier would be required to fund the 30%, and they would be eligible for the programs without meeting a cost per receptor threshold. Councilor N. Murphy then shared that there were two other bills: HB1649, a PFAS bill, heard on Tuesday afternoon, and is relative to prohibiting certain products with intentionally added PFAS, and HB1393, which was heard yesterday by health and human services, and is relative to the long-term impacts of pediatric cancer. Lastly, she shared that HB1068 was heard yesterday by health and human services as well, and is relative to blood testing for children, specifically lead and the long-term health implications.

He shared that part of the project to upgrade their information system to CSI is to upgrade their technology. This was agreed upon back in 2021, but the purchases were not made, so he is present to request the funds now to complete the purchases, which will be the iPad devices and removable mounting bracket systems.
