- 2. Eliminate employee 10% health insurance premium cost share. Which would cost employees the following for 2016-17 if plan was not changed:

Single	\$1,081
2-Person	\$2,162
Family	\$2,918

3. Eliminate reimbursement for difference between tier 2 and tier 3 prescription co-pay effective July 1, 2016. Motion passed unanimously 7-0-0.
