Director's Report

- Budget Update
 - MYA Petitioned Warrant Article – for Greenfield Farm athletic fields – on for Deliberative Session – if voted for, will go to the ballot in April 2024
 - Corporate Partners for current field use from Elbit & Getinge
 - \$1,000,000, cost; adds \$0.22 per thousand per house in tax base

- Have needed these fields since 2010
 - Deliberative Session Wednesday, March 13th, 7:00 pm – JMUES
 - Has to be approved for the amount to go to ballot at that amount
- Summer Camp
 - Registration – registration open for 6 weeks, 80% full, teen camp is 60% full; as of 2/20/24, had 1205 registrations for summer
 - Staffing Needs – counselors have been confirming; need 18 & older for teen camp, cook, archery, weekend park attendant for beach, weekend life guard coverage
 - Minimum age – 18 except for lifeguards, which is 16 years old; lifeguards start at \$16/hour; will reimburse for course if you come to work for the camp for the summer
- Upcoming Special Events
 - Winter Carnival Saturday, February 24th 12:00 – 3:00 pm
 - Consider changing date in future
 - 33 groups/businesses coming
 - Games/activities
 - MMFF selling food/baked goods
 - Good weather expected – all outdoor event
 - Easter Egg Hunt Saturday, March 23rd 10:00 – 11:45 am
 - Giving away 6500 Easter Eggs due to cost of eggs
 - Usually draws 1000+ people, depending upon weather
- Miscellaneous Updates:
 - Ice Skating rink open again
 - Was open for a week in January, then a few days in February
 - This open period may be the last for the season, depending upon forecasted
