 - Septic Line Failure – Public Works dug up the area to fix it and uncovered more issues with the piping system which are being addressed
 - Pickleball Courts – 8 more sets of blue pickleball lines were painted at the tennis courts
 - Bids will be out soon on 5 roof cabins
