We are writing to invite you to join us in 2018 at the Merrimack Summer Farmers' Market. The 2018 market will be held on Wednesdays at Vault Storage, 526 DW Highway, Merrimack, NH from 3:00 p.m. to 6:00 p.m. Enclosed please find the Rules and Regulations and an application for the 2018 season.

The 2018 market will run from June 14 through October 11, 2018. This year the annual fee for a space at the summer market will be \$125.00 for the full 18-week season. Numbered spaces will be issued for the entire season on a first-come, first-serve basis. **We must receive your completed application, as well as your fee, proof of insurance and/or any licenses that you are required to hold, before we can issue your permanent numbered space.**

To be fair to all vendors, we will only be accepting a limited number of vendors for each category on the application form. **PLEASE NOTE THAT WE CURRENTLY HAVE A MEAT, MAPLE SYRUP AND HONEY VENDOR. YOU MAY SELL OTHER PRODUCTS WITH PRIOR APPROVAL THAT YOU HAVE AVAILABLE, BUT YOU WILL NOT BE ABLE TO SELL ANY OF THESE PRODUCTS.** Therefore, we ask that you be specific about the products that you will sell and only sell those items that you have identified on the 2018 market application. A waiting list will be maintained in the event an opening occurs in any category. We also encourage our vendors to use our market as a CSA pick-up point.

The 2017 season was very exciting and vibrant. We look forward to seeing you at the market on June 14, 2018.
