New Business:

- a) Community Garden Rules There should be information by the January 15, 2014 on Merrimack TV. Bob will also be speaking in the Klump Room downstairs at the library at 7:00 p.m. on March 11, 2014.
- b) **Results from Farmer's Market Survey**. Vendors had several concerns. They feel some of the vendors are bringing too many things to sell other than their own crops. They miss the Fish lady. The vendors at the Farmer's Market would like more on-site contact with the Agricultural Commission members. They would like the season to be extended through mid-October. And perhaps a more visible lot for their weekly displays to be seen from the road.
