- 5. Don L. wanted to know what our overnight use of campers in Horse Hill parking lot is. Don L. and Lynne W. have seen a trailer parked overnight. Six properties of Merrimack Conservation Committee have a half hour sunset policy. HHNP is a preserve not a park therefore we are open 24/7 but with no camping!
