Hi Eileen

The Rotary Club of Merrimack has funds remaining that they had previously earmarked for Twin Bridge Park / Kids Cove. After talking to Lori Barret and I about the needs of the park, we came up with the idea of not only replacing the old and broken trash barrels at Kids Cove Playground, but also the idea starting to recycling at the playground. Currently there are no recycling barrels in any of our parks and this would be the first one.

We found a stainless steel trash / recycling barrel combination that will look good in the park and DPW will begin separating out the recycling when they do trash pickup at Kids Cove. If this goes well, we can look at slowly expanding recycling to other parks in the future.

The cost of the trash/recycling barrel that we found (with shipping) was \$1,226.93; which is the amount they are donating.

Material

The 64 gallon recycler is 37.82" tall and is composed of 12-gauge slotted steel panels with a .38" wide gap uniform pattern. The words TRASH and RECYCLE are cut into the steel on the front, back and adjacent panels. The cut-in lettering is 2.25" high x 10.88" wide for "TRASH" and 2.25" high x 14.89" wide for "RECYCLE". The bonnet top is made of 16-gauge steel and features a 12" square, top loading waste opening. The top includes a 14" security strap and lifts off for easy trash removal.

Optional decals are available: "Bottles/Cans", "Mixed Recycling" or "Paper" with recycling logo or "Trash" decal—custom decals also available. Specify black or white lettering. Decals will be factory installed and must be specified at the time of order.

The recycler is designed to be portable for flexibility in placement or surface mounted using pre-drilled .50" diameter holes inside the base to prevent movement. Mounting hardware is not included. The rubber feet are adjustable to assist in leveling the receptacle. Recycler includes two reusable plastic liners made of high-density polyethylene.

Finish

The recycler body is protected by the patented Fusion Advantage™ finish. The plastisol coating has an average thickness of .125" and is encapsulated with a richly tinted, high performance powder coating that won't rust, fade, peel, chip, crack, mold or mildew. The finish has been tested to the requirements of ASTM E1354 and determined to be in compliance with California Uniform Fire Code 1103.2.1.4.2.

Fade-resistant, powder coated steel tops features a state-of-the-art primer proven to prevent rusting. Treated components exceed the industry standard by 34% in testing by independent sources.

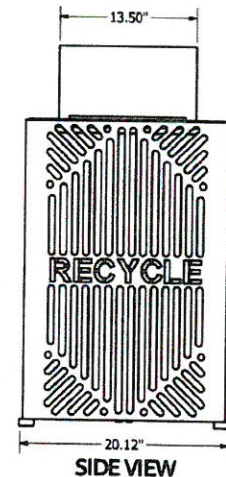
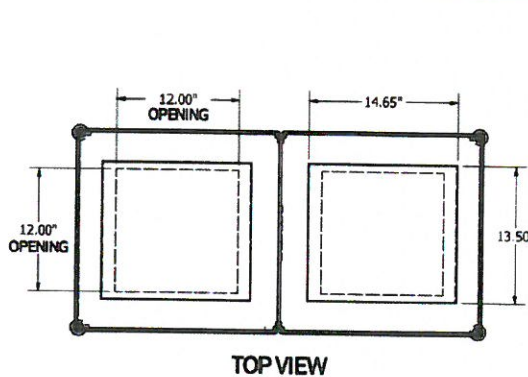
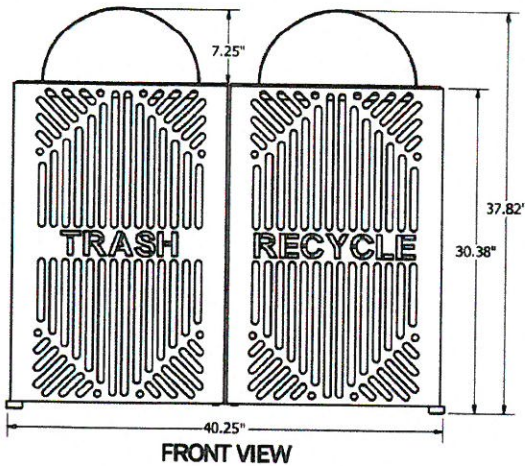
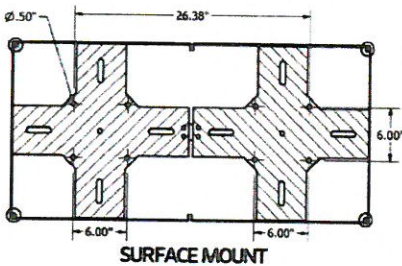
The recycler ships fully assembled and ready for use.
