Dear Ms. Cabanel:

I am writing in response to your letter to Phillip Miles requesting to acquire an easement over a portion of a State owned parcel designated as Merrimack Tax Map 5C-659 (Parcel 1081) to finalize the Town Center Loop Trail.

The Department has reviewed your request and the Department needs to preserve all rights and interests for this property for the proposed Nashua –Bedford 13761 F. E. Everett Turnpike (F.E.E.T.) widening project at this time. The Department anticipates having a consultant beginning work on this project this summer.

This parcel is within one of the segments of the proposed F.E.E.T. widening and offers the potential to address environmental impacts in the same watershed, potentially avoiding the need for mitigation payments. Additionally, it could be useful in meeting the broader needs of preservation or mitigation of environmental impacts for the three segments identified for widening.

However, the Department would certainly be amenable to considering the Town's request for a conservation easement for the entire parcel as a mitigation element of the proposed project since wetland impacts will be inevitable as a byproduct of the widening. The earliest the Department could be in the position to make this determination would be the summer of 2016.

Hi Pete and Eileen,

As the State reaches out for public comment on the widening of the FE Everett Turnpike, I am hoping our Town officials will carefully re-address this desire for the MCC or the Town to either gain ownership or an easement over the State land that abuts Wildcat Falls. This is the land acquisition needed to have the Town Center trail from Watson Park to Wildcat Falls become a reality using locally controlled land.

I am writing concerning the Town's interest in acquiring a parcel of State owned land consisting of approximately 56 +/- acres located on the westerly side of the FE Everett Turnpike, south of Baboosic Lake Road in the Town of Merrimack.

The Department has reviewed its need for this parcel and has determined that this parcel is not surplus to our needs and will be retained by the Department at this time. The Department has identified a need for the future widening of the FE Everett Turnpike in the direct vicinity of this parcel. This parcel is located within one of the segments of the envisioned FE Everett Turnpike widening and could be used as preservation or mitigation of environmental impacts for the segments of future widening.

Once the project's specific needs are understood, the potential sale of this parcel to the Town can be further discussed.

The Town of Merrimack would like to express our interest in acquiring a parcel of land in our Town that is owned by the State of New Hampshire Department of Transportation (NH DOT). The parcel is shown on Merrimack Tax Map 5C as parcel 659 and contains approximately 56 acres. The parcel is bordered to the west by Town of Merrimack land that is managed by the Conservation Commission, to the east by the Everett Turnpike and then by Merrimack School District land, and to the south by the Souhegan River. It is located just to the west of the Merrill's Marauders Bridge which spans the Souhegan River for the Everett Turnpike.

Merrimack's desire to acquire the parcel stems from three different goals. First is the Conservation Commission's goal of securing property along the Souhegan River to ensure a healthy river for years to come for the enjoyment of our residents and the different species that live in and along the river. Second is the Commission's desire to manage the wetland areas in our Town that are essential to both our ground water system, which Merrimack exclusively draws from for drinking water, for its residents and to preserve the unique wildlife habitats found in these wetlands. The third goal is to create and maintain a system of trails throughout the Town Center Area that provides connectivity to recreation areas, conservation and wildlife habitats, as well as points of interest in the Town Center Area.

Merrimack's interest in this parcel began in 1970, when the Department of Transportation sold Merrimack the abutting parcel for \$1.00. Members of the community and the Conservation Commission drew up recreation and conservation plans that inevitably included the remaining NH DOT parcel. In the late 1980s and early 1990s, members of Merrimack's Heritage Trail Committee envisioned a Town Center Loop as part of the Heritage Trail, to connect Wildcat Falls with other locations of interest in the Town Center Area. The portion of the Trail that was on Town land was developed and remains a very popular trail, but the Everett Turnpike was an obstacle to completing the loop.

In 2008, the NH DOT Bureau of Bridge Design presented to the Town a proposal for replacing the Merrill's Marauders Bridge. During the Bridge Design meeting, members of the public and the Town Council (including myself as I was member of the Town Council at that time) talked with Steve Liakos and his associates from the Bureau of Bridge Design about Merrimack's strong desire for passage under Merrill's Marauders Bridge. Those discussions lead to a signed encroachment agreement between the Town and NH DOT. The Town purchased a pedestrian bridge, and during renovation of Merrill's Marauders Bridge the State's contractor installed the pedestrian bridge. Along with the pedestrian bridge, the NH DOT provided safe passage under the Merrill's Marauders Bridge on both the north and south side with appropriate fencing to ensure pedestrians would remain out of harm's way.

The Town then worked with the Nashua Regional Planning Commission to create a Town Center Plan that included a Town Center Trail that utilized the new access under Merrill's Marauders Bridge. It tied Town owned parcels to the east of the Everett Turnpike to Town owned parcels to the west. The Town purchased one privately held parcel that was on the trail route, and is completing an easement with the Merrimack School District for the section of the trail that passes over their property. The final parcel required to make this Town Center Trail a reality is owned by the NH DOT – the parcel about which I am writing you today.

As I stated earlier, the Conservation Commission has goals for this parcel that include protecting the Souhegan River and the various wetlands on this property. Over the many years since 1970, members of the public have been walking, riding, and enjoying the NH DOT parcel. Unfortunately, some of that recreation has encroached on the wetlands of the parcel. Trails are crossing the wetlands without proper bridging and are being used by both motorized and non-motorized users. The wetlands and the surrounding areas are seeing erosion issues along with inappropriate wetland crossings. The Commission believes this type of activity needs to be controlled and managed and would like to be more active in doing that.

When you combine the desire to realize a Town Center Trail that utilizes the access provided by the NH DOT with the goals for active conservation management, you can see why the Town of Merrimack is so interested in acquiring this parcel through its Conservation Commission.

I have included a map with this letter to show the intent of the Town Center project as it is related directly to this parcel and the Town parcel directly to the west. You will see on the map that a trail system already exists on the NH DOT parcel as it was created over these last 40 years by the public. I have also included a map that was created by the Town Center Committee and approved by the Town Council that depicts the full Town Center concept including the Town Center Trail as it would proceed under Merrill's Marauders Bridge.

The Town, upon acquiring this parcel, would formalize the trails, and develop a long term conservation, maintenance, and use plan for the parcel. It would then proceed to realize the Town Center Trail that has roots going back to the 1980s.


