Date: February 7, 2019

On January 7, 2019, a petition to place a warrant article on the 2019 Town Warrant and ballot was filed with the Town Manager's office and forwarded to the Town Clerk's office for verification.

According to Town Charter, section 10-1,B, petitions must be signed by at least 50 registered voters. Although the signature verification process is not defined in Article 10-1, section B, the method used was that as defined under Article10-2, section A. This section states that "within seven (7) days after the filing of an initiative petition, the Town Clerk shall ascertain by what number of registered voters the petition is signed, and shall attach thereto a certificate showing the result of such examination".

Due to staffing issues in the Town Clerk's office, the Supervisors of the Checklist examined the list signatures submitted and compared the same against the current voter checklist. I am just now getting this report to you.

124 signatures were submitted with the petition. One was determined to be a duplicate. Of the remaining 123 signatures, 73 have been verified, and 50 have been rejected as they are unregistered voters.

It has been determined that the petition meets the 50 signature requirement under the Group Petition Process of section 10-1, B. of the Town Charter. The petition is attached and is being returned to you.

I would like to have the topic of "having the residents of Merrimack vote to allow Keno games to be operated as prescribed by state law within Merrimack" placed on the Town Council agenda.

Citizens who wish to participate in this form of entertainment currently take their business out of town (Nashua, Milford, Hudson, Manchester to name a few) which takes away revenue from the local businesses. This lost revenue is from existing food & beverage sales which can't be recouped. There is also the loss of potential revenue from Keno sales.

I've attached a petition with signatures from Merrimack citizens which was briefly circulated to patrons from the Jade Dragon, Zhong's, the VFW & the American Legion

The owners of the Jade Dragon specifically asked me to find out what steps needed to be taken so they could offer Keno to their customers. Zhong's had contacted the lottery themselves and had started their own petition which was added to list of signatures accompanying this request
