AMENDMENT OF CHAPTER 183 VEHICLES AND TRAFFIC

The Town of Merrimack ordains the following:

Chapter 183 is amended by adding the following new Section 183-23:

Chapter 183 Vehicles and Traffic

Article III. Parking Restrictions

[**§183-23 No Parking Areas.**

A. The following areas are designated as no parking zones, to include the entire width of the travel lanes and road shoulders:

- (1) Currier Road**
- (2) Souhegan Drive**
- (3) Birch Street**
- (4) Tiffany Lane**
- (5) Pinehaven Drive**
- (6) Fir Street]**

This shall become effective upon passage.

AMENDMENT OF CHAPTER 183 VEHICLES AND TRAFFIC

The Town of Merrimack ordains the following:

Chapter 183 is amended by adding the following new Section 183-23:

Chapter 183 Vehicles and Traffic

Article III. Parking Restrictions

[**§183-23 Temporary Parking Regulations.**

- A. The Town Council and/or Police Chief may issue temporary parking bans under exigent, special, or extraordinary circumstances, or during special events. It shall be a violation of these regulations to stop or park a motor vehicle in a manner that is contrary to the official posted signs indicating a temporary parking ban is in effect.**
