## § 183-21. Violations and penalties.

Any person, firm or corporation violating the provisions of this article shall, for each violation and upon conviction thereof, pay a fine of not more than \$500.

#### § 183-22. Registered owners.

Any motor vehicle parked or left in violation of any part of this article shall be presumed to have been left by the registered owner thereof. Such presumption shall be prima facie evidence of responsibility for such violation.

## §183-24 Residents Only Parking Areas.

- A. The following areas are designated as residents only parking areas with parking restricted to Merrimack residents, said residents to be identified by the Merrimack Transfer Station sticker displayed on the vehicle that is available to Town residents:
  - (1) Birch Street
  - (2) Currier Road
  - (3) Fir Street
  - (4) Hemlock Street
  - (5) Pinehaven Drive
  - (6) Souhegan Drive
  - (7) Tiffany Lane
- [B. Any person, firm or corporation, violating the provisions of subparagraph A shall, for each violation and conviction thereof, pay a fine of \$50.00 for the 1<sup>st</sup> such offense, \$100.00 for the 2<sup>nd</sup> such offense, and \$150.00 for each offense thereafter.]
