SUBJECT: Request to expend from Equipment Capital Reserve Funds

The Department of Public Works is preparing to work with the Finance Department to solicit bids for a number of vehicles and pieces of equipment that were included in the approved 2022-2028 Capital Improvement Program. I am requesting that the Town Council be asked to approve withdrawal of budgeted amounts from the appropriate Equipment Capital Reserve Funds (CRF) for the vehicles and equipment.

The volatility in the market for vehicles and equipment has been evident in recent bids with vendor bids including language indicating pricing on the bid is only good for very limited time frames. This volatility makes it difficult for the Town to obtain the best pricing and to react to the limited supply. With the authority to spend up to an approved amount on vehicles and equipment, the Town can better execute bids to procure the best equipment for the Town at the best price. The vehicles and equipment that we are seeking approval to fund through CRF withdrawals are listed below with an expected 'not-to-exceed' budget amount.
