**RE: AGENDA REQUESTS/ ACCEPTANCE OF HIGHWAY SAFETY GRANTS**

---

The four agenda requests before the Town Council for acceptance of the NH Office of Highway Safety Grants include “Driving Under the Influence”, “Distracted Driving”, “High Visibility Mobilizations” and “Speed Enforcement Patrols.”

The Merrimack “DUI Patrols” grant is in the amount of \$2,600.00 and would fund 8 four hour patrols between the hours of 9 p.m. and 3 a.m. These patrols would focus on detecting DWIs and would predominately be held on Thursday, Friday, and Saturday nights. We may schedule patrols around special events such as the Super Bowl and St. Patrick’s Day, which are known events that are focused around alcohol. This past year we conducted 3 patrols which resulted in 4 arrests. Officers stopped 30 vehicles during the patrols and issued 34 warnings for various offenses as well as 5 summonses.

The Merrimack “Distracted Driving Patrols” grant is in the amount of \$2,611.58. This grant would fund 8 four hour patrols between the hours of 7 a.m. to 11 a.m. and 3 p.m. to 7 p.m. This grant would focus on patrols to address distracted and negligent driving which may be caused from using a handheld electronic device, other distractions in the car, failing to clear snow from vehicle, etc. This past year we conducted 9 patrols. Officers stopped 111 vehicles during the patrols and issued 93 warnings for various offenses as well as 16 summonses.

The Merrimack “High Visibility Mobilization Patrols” grant is for the combined amount of \$3,400 which would fund 12 four hour patrols consisting of “Join the Clique,” “Drive Sober or Get Pulled Over” and “U Drive, U Text, U Pay” mobilizations. These high visibility mobilizations are statewide coordinated events that are conducted on specific dates and times to enforce specific issues. This past year we conducted 6 patrols. Officers stopped 81 vehicles during the patrols and issued 85 warnings for various offenses as well as 10 summonses.

The Merrimack “Speed Enforcement Patrols” grant is in the amount of \$1,600.00 which would fund 5 four hour patrols. The grant would focus on patrols to address problematic motor vehicle speed issues in town. This is the first year the Town of Merrimack have received Speed Enforcement grant money as part of our package.

All four grants require 25% In Kind Match or Soft Match from the Police Department.

The awarded funds for these highway safety grants is a valuable benefit for the Town of Merrimack. Generally, officers on patrol face a very high volume of “calls for service” which frequently diverts their attention away from enforcing motor vehicle violations. Instead of being out on patrol and attentive to motor vehicle issues, the officers are in the station or at residences and businesses handling calls for service. The grant patrols offer us the opportunity to deploy dedicated officers whose main focus is the enforcement of motor vehicle violations with the ultimate goal of improving the safety of the motoring public by lowering the frequency of fatal, personal injury and property damage related motor vehicle accidents.
