Mr. Micali,

I am requesting a withdrawal from the Fire Department Equipment Capital Reserve Fund of up to \$152,902.00 for the purchase of two (2) new vehicles/equipment that were included in the approved 2022-2028 Capital Improvement Program.

This equipment request includes a four-wheel drive pickup with a plow that would replace an existing 1988 pickup, and an admin vehicle for fire department emergency response. The Department will review the admin vehicle fleet to determine which vehicle should be removed from service.

As you are aware, the dealerships we are working with have limited inventories and the sooner we can place an order, the sooner we will be able to purchase. If the request is approved, I will work with our vendors and get the orders placed as soon as possible.

The vehicles being removed from service could either be traded in or go to auction.
