## **MEMO**

RE: RADIO INFRASTRUCTURE GRANT

Back in May of 2021, the Merrimack Police Department and Fire Department were looking to upgrade to an 800 MHz digital trunked radio system to alleviate current coverage issues. Specifically, both departments had radio coverage issues while trying to transmit inside large structures (i.e. Fidelity Investments, Anheuser Busch, Elbit Systems, Merrimack Middle School, etc.) and other geographically compromised areas. Changes in topography over the years also contributed to this (i.e. tree growth, large scale developments, new buildings, etc.). The 800 MHz is a much narrower bandwidth than our current VHF system, which allows it to penetrate into large structures. Radio testing conducted using 800 MHz portable radios proved that the radio signal worked within our trouble areas. It was determined that our current VHF system had to be upgraded.

The project required the purchasing of dual band radios for every officer and all mobile radios for Police and Fire vehicles/apparatus. There were also costs related to installation, programming, system integration, engineering, and staging. Lastly, the project required the purchase of a radio tower and construction of a communications shelter to safely house all the equipment at the tower site. The total cost for the project was \$1,471,745.93.

As the costs related to this project are exorbitant, we submitted a Congressionally Directed Spending request to the Office of United States Senator Jeanne Shaheen on May 18, 2021. As a member of the Senate Appropriations Committee, Senator Shaheen looks to ensure that the federal government invests in programs that provide assistance to New Hampshire communities. Funding for this project would fall under the Department of Justice, Office of Community Oriented Policing Services (COPS).

I am pleased to announce that after submitting the request, we were approved to receive the entire \$1,471,745.93 applied for to compete this project.
