Please note that James Taylor has declined to renew his membership on the Souhegan River Local Advisory Committee (SoRLAC). A letter thanking Mr. Taylor for his service is attached.

With Mr. Taylor's departure, SoRLAC is invited to identify another individual interested in serving on the Committee. Currently, Merrimack is represented on SoRLAC by one resident. SoRLAC members must reside in New Hampshire and may represent a broad range of interests including local government, business, conservation interests, recreation, agriculture, and riparian landowners (those who own property adjacent to the river). Each member serves a term of three years. In the past, the NH Department of Environmental Services has found municipal officials - including planning board members, conservation commissioners and selectmen - to be valued and dedicated committee members.
