SUBJECT: Request to Purchase Wheel Loader WWTP / Bid Recommendation

The Wastewater Treatment Plant (WWTP) is requesting permission from the Town Council to withdraw \$248,900 from the Capital Reserve Fund for the purpose of purchasing a new 2023 Caterpillar 938 wheel loader. The CIP identified a budget estimate of \$250,000 per the approved 22-29 CIP. The new wheel loader will replace the existing 2006, 938 loader. The existing vehicle will be traded toward the purchase of the new wheel loader.

Loader Operation

The wastewater composting facility has three wheel loaders, it is necessary to have the three machines to insure a minimum of two machines at all times in case of breakdowns. The current Caterpillar loader has a larger light material bucket. This machine is used primarily to move the 1,500 yard windrows of compost, manage the sawdust and to load large dump trailers of approved of compost. This larger bucket makes both of these operations much more efficient.

Other key factors are, the loader that mixes the raw sludge cannot be used to load approved material because of the need to prevent cross contamination with approved material. The two John Deere loaders only have 4 yard buckets, which makes them less efficient for moving windrows and filling large dump trailers.

We provide a service to not only the residents of Merrimack but also the eight other communities who bring the bio-solids to be composted and who pay tipping fees to the town of Merrimack.

Recommendation

On November 7, 2023 The Wastewater Treatment Plant conducted a bid opening and we received six bids for wheel loaders. The results are as follows;

•	Develon (Doosan)	Bid Price; \$236,000.00, Trade Allowance \$30,000.00, Total Bid \$203,000.00
•	JCB	Bid Price; \$265,000.00, Trade Allowance \$30,000.00, Total Bid \$235,000.00
•	Caterpillar	Bid Price; \$298,900.00, Trade Allowance \$50,000.00, Total Bid \$248,900.00
•	Volvo	Bid Price; \$286,000.00, Trade Allowance \$35,000.00, Total Bid \$256,000.00
•	John Deere	Bid Price; \$309,000.00, Trade Allowance \$45,000.00, Total Bid \$264,000.00
•	Case	Bid Price; \$292,150.00, Trade Allowance \$25,000.00, Total Bid \$267,150.00

The Develon wheel loader, also known as Doosan was the apparent low bidder followed by JCB and Caterpillar, although Develon was the apparent low bidder I am recommending the purchase of the Caterpillar for the following reasons;

- With the exception of Caterpillar, lead times for delivery of all the machines outfitted as specified in the bid package range from 3 months to 1 year. Caterpillar is the only bidder that can provide the specified machine immediately. This is important because current loader is to be used as trade and we cannot be without a backup machine for 3 months to a year.
- 2. Develon also took exception to six different parts of the bid. The most concerning exception was; Section 16, Parts Availability, they were the only bidder to make an exception. They indicated that it was an unclear explanation in the bid document. This is concerning because if the machine breaks there may be long lead times for parts which will also leave us without a backup machine.
- 3. Caterpillar was bid by Milton Cat which has multiple locations throughout New England with the closest one located in Londonderry NH. The current loader being replaced has served the town well with few problems and has been in constant use for the past 17 years

SUBJECT: Request to Purchase Engine Driven Welder WWTP / Bid Recommendation

We went out to bid for the engine driven welder identified in the Minor CIP 2022-29. The estimated cost of the welder is \$7,500.00. We received three bids for this unit on November 7, 2023. The results are as follows:


Grainger \$8,280.00

Technology International Inc. \$8,450.00

KV7 Resources; \$8,477.70

I recommend that we reject all three of those bids because we have a confirmed price of \$7,500.00 from Air Gas East, which was on the bidders' list but did not submit a bid. It is the same welder specified in the bid and at approximately almost \$900.00 less than the low bid, it does not make sense to not purchase the unit from Air Gas East. I have included the bid results and the quote from Air Gas East.

We respectfully request the release of the \$7,500 identified in the Minor CIP to purchase the welder from Airgas East.
