F.E. Everett Turnpike Widening in Merrimack

Request for withdrawal of Funds from the Sewer Capital Reserve Fund

NH DOT is working on the widening project 13761-E that will widen the Highway from 2 lanes to 3 lanes between Exists 12 and 13. Within this segment of Highway we have a sewer line crossing under the Highway near Dumpling Brook.

When they widen the road they will be placing additional fills over our sewer pipe. We had our engineer Wright-Pierce look at this pipe and determined that it was is good working order. We also had them put flow meters to determine how much flow is going through this pipe. It was determined that we do not need to increase the size of the pipe.

In order to maintain the integrity of this pipe, they will need to sleeve the pipe under the areas of fill. This will tie into the existing sleeve that currently runs under the Highway. The State and their contractor have determined that this work will cost the Town \$90,696.21. Since the Town owns the sewer pipe we are responsible for the work being done on the pipe.

In order to proceed with the work, the State is requesting a check in the amount of \$90,696.21. Therefore, we are requesting the Town Council release the monies from the Sewer Capital Reserve Fund and to authorize the Town Manager to sign any and all documents.

The Department has received the revision after proposal bid prices from R.S. Audley. Inc. dated September 15, 2023 for the extension of 30" steel casing around the existing 12" HDPE sewer main carrier pipe on the above noted State project in Merrimack, New Hampshire. The proposal has been reviewed by this office and incorporated into the construction contract estimate with the Utility Amendment to Agreement in the amount of \$90,696.21 which includes the deduction of \$2,048.90 for reimbursement of trench and backfill.

Enclosed is the original Utility Amendment to Agreement in duplicate, executed by the State. If this Agreement is satisfactory, please have both signed and dated for the Town and return one (1) to Lennart D. Suther, P.E., Utilities Engineer, New Hampshire Department of Transportation, 7 Hazen Drive, PO Box 483, Concord, NH, 03302-0483. The second Agreement is for your records.

Please prepare a check in the amount of \$90,696.21. Checks should be made payable to the "Treasurer, State of New Hampshire" and forwarded to Accounts Receivable Supervisor, Bureau of Finance and Contracts, New Hampshire Department of Transportation, 7 Hazen Drive, PO Box 483, Concord, NH 03302-0483, with a copy to Michael Mozer at the address stated above. Should funds not be provided, the extension of 30" steel casing around the existing 12" HDPE sewer main carrier pipe work will be deleted from the contract.

#### AMENDMENT TO AGREEMENT

This Amendment to Agreement is made in duplicate this <u>27</u> day of <u>2023</u>, by and between the STATE OF NEW HAMPSHIRE, by its Department of Transportation, party of the first part, hereinafter called the "State", and Merrimack Public Works Department (Vendor #177436), a municipally owned utility, party of the second part, hereinafter called the "Town".

#### WITNESSETH:

WHEREAS, the State and the Town entered into a Utility Agreement dated the 21st day of March, 2023, for the relocation of sewer main facilities, on the above referenced State project in the Town of Merrimack, County of Hillsborough, New Hampshire, and,

#### Revise the second Paragraph to read:

WHEREAS, the State has a Turnpike Capital Program Project (Organization Code 7507), NASHUA-MERRIMACK-BEDFORD, 13761-E, for the construction of widening a 2-lane section of the F.E. Everett Turnpike from Bedford Road to Exit 13, in the Town of Merrimack, County of Hillsborough, New Hampshire, which construction necessitates the extension of 30" steel casing for existing 12" sewer main carrier pipe to the extent required to permit construction of the Project, and,

#### **Revise** the sixth Paragraph to read:

WHEREAS, the Town desires the sewer main sleeve extension installation to be included as part of the Highway Contract, and,

WHEREAS, the aforementioned Utility Agreement is to be amended to extend the existing sewer main sleeve around the existing carrier pipe for the Project, and,

NOW THEREFORE, in consideration thereof, the parties hereto mutually agree to amend this Agreement as shown on the attached plans and described as follows:

#### Amend Paragraph 1 to read:

1. The State agrees to provide labor, equipment, and materials in the Contract for the extension of a 30" steel casing around the existing 12" HDPE sewer main carrier pipe at the following approximate locations:

#### **Amend** Paragraph 7 to read:

7. The Town agrees to remit payment to the Treasurer, State of New Hampshire, through:

Bureau of Finance and Contracts
New Hampshire Department of Transportation

Concord, NH 03302-0483

in the amount of the bid item totals, plus construction engineering estimated at 6%, fuel adjustment, and 10% for overhead expenses, minus the reimbursement amount, for the non-participating sewer main sleeve extension and carrier pipe installation work described in Paragraph 1 prior to the award of the Contract. The actual payment total required will be provided prior to the work. Should the funds (approximately \$90,696.21) not be provided, the sewer main sleeve extension and carrier pipe installation work in excess of that length required to be relocated due to construction conflicts will be deleted from the Contract; and the Town will be billed for the costs of the required relocated length, minus State reimbursement.

#### 3

#### **Amend** Paragraph 9 to read:

9. The State agrees to reimburse the Town the amount of \$2,048.90 for trench and backfill. The Town agrees that this amount, to be deducted from the payments described above, fulfill the State's obligation of RSA 228:22 trench and backfill.

All other terms and conditions of said Agreement remain unchanged.






