33 **1. Petition Warrant Article – “Stop Sanctuary Cities”**

34 *Submitted by Albert “Max” Abramson*

35 The Town Council to consider moving the following filed petition warrant article to the 2024 Town
36 Warrant to be considered and voted on by the Town of Merrimack residents, pursuant to Article X,
37 Citizens Initiatives, of Town of Merrimack Charter:

38 "To see whether police officers shall be permitted to enforce federal immigration laws, comply with
39 immigration detainer requests, or contact federal immigration authorities to conduct a background
40 investigation on anyone arrested on evidence of any other crime. No school district nor town official
41 shall establish "Sanctuary Cities" policies that prevent immigration laws from being enforced by any
42 police officer nor federal immigration officer in the performance of their job. Four towns, Cheshire
43 County, and the City of Manchester have enacted "Sanctuary City" policies for illegal immigrants
44 without notifying the general public beforehand. A Yes vote is to stop our community from being
45 turned into a Sanctuary City."

2 Albert “Max” Abramson was not present initially to discuss this filed petition warrant article, but Mr. Micali
3 shared that he spoke with legal and was informed that the Council has two options: they can decline to put
4 this on the ballot because Merrimack is a budget Charter town, meaning that the Charter states that only
5 monetary items should be voted on at town elections, or if the Council would like, they can choose Charter
6 Article 10-4, Submission of Proposed Measure, where it states that the Council of its own motion may
7 submit any measure or proposition for repeal or amendment of a measure to the voters at any regular or
8 special Town election. A public hearing would still need to be held within 60 days of receipt of the petition,
9 so either of the two upcoming Town Council meetings in March. Mr. Micali clarified that if this is moved to
10 the Warrant, than this would be discussed at the deliberative session as well. Councilor Hunter asked if the
11 citizens could make changes to this at the deliberative session, in which Moderator Lynn Christensen stated
12 that yes, any article on the Warrant can have changes made to it as long as the subject of the article is not
13 changed. Councilor N. Murphy asked Ms. Christensen what would happen if the Council did not put this on
14 the Warrant, in which Ms. Christensen stated that this should be put on the warrant to let the voters decide
15 what to do with it, regardless of it being a budget issue or not.

17 Mr. Abramson arrived after some initial discussion between the Council and Ms. Christensen to speak on his
18 petition article. He shared that the policies in some states cannot contact Immigration and Customs
19 Enforcement or are not even allowed to check records in other countries. He stated that this is not a race or
20 nationality issue, this is an issue of an officer needing to be able to do their job, which is to protect and to
21 serve their community. He shared that this wouldn’t be legally binding, but it would state that the town
22 wouldn’t be able to interfere with what officers do. Councilor N. Murphy questioned if this should be a state
23 issue instead of an individual community issue. Vice Chair Harrington suggested modifying the language
24 and removing the wording on the school and the other towns, but Ms. Christensen stated that it cannot be
25 changed until the deliberative session.

27 Don Chisholm of 55 Bates Road shared that he is for the idea of this petition and is also pro-immigration,
28 done right. He is wondering when the Council will decide when they will put it on the ballot, in which
29 Chairman Rothhaus stated that they will be voting on this issue shortly.

31 Mr. Micali stated that he received the below email from Kathy Komar of 44 Belmont Dr:
32

33 Good morning Mr. Micali and Town Council members,
34 This email is in reference to the item on the Town Council meeting agenda this evening. Please vote in favor
35 of putting on the ballot the need to vote that we as a town do not become a sanctuary city. Merrimack should
36 not become a sanctuary city and we should allow our police officers to do their jobs and arrest, question,
37 hold, detain, and deport any and all illegal aliens. There is a process for immigration, and that the law should
38 be followed. Thank you for your time.

43 Councilor N. Murphy shared that she cannot support this petition warrant article as it was not brought
44 forward by or recommend by the police department, and they do not run their police department by warrant
45 articles. Further, there is no funding to support this warrant article, and she sees this as a national issue being
46 brought to the community. Councilor Koenig agreed with Councilor N. Murphy, stating that he doesn’t
47 believe that this is a problem in Merrimack, and that since this isn’t enforceable by law it would cause
48 confusion or dissention within the town. Chairman Rothhaus agrees with this, feeling that police officers
49 would already take proper steps if contacted by ICE. Councilor Healey feels comfortable putting this forward

1 as it's part of the process and the citizens have spoken, and this allows for the citizens to have a voice at the
2 deliberative session to hash this issue out; Councilor Hunter agrees with Councilor Healey's stance.
