Re: HB 1101 Comment Letter

Dear Representatives Berry, Richardson, and members of the Science, Technology and Energy Committee:

Thank you for the opportunity to provide comments on HB 485, which seeks to establish new standards for devices emitting air pollutants which have the potential to harm soil and water because of air deposition and establishment of certain water quality standards.

The Town of Merrimack (Town) is deeply concerned about the perfluorooctanoic acid (PFOA) and perfluorooctane sulfonate (PFOS) contamination in the environment. By now, I'm sure that you and your committee are quite familiar with the contamination issues that have been experienced in Merrimack, Litchfield, Bedford, Amherst, and the Pease Tradeport areas. For more than 2 years, the Town has been trying to work with affected residents, the Department of Environmental Services (DES), and St. Gobain Performance Plastics to come up with solutions to the contamination issues. Time and time again, the Town has been unable to adequately address the situation, due to a lack of NH standards for contamination levels and the reliance on the US EPA for advisory standards that are not enforceable by DES or any other state/local agency.

The Town is committed to the public to remain vigilant regarding the safety of its citizens and make every effort to keep abreast of the myriad complex issues related to this problem. The Town of Merrimack has always been at the forefront of protecting public health and the environment and agrees with regulations that are based on sound science and research. Foremost, we are all supportive of safe drinking water – that is what the professionals in the Town help ensure every day.

We believe that coupled with the language in HB 485 (which is currently in the House Science, Technology and Energy Committee) this bill would provide DES with the capability and tools to respond to not only to the known PFOA/PFOS issues (both groundwater quality and air emission standards), but also to emerging contaminants, and provide enforceable standards that would not only benefit Merrimack, but the state as a whole.

The Town urges the committee to look favorably on this bill which would provide DES with the tools they need to address contamination issues now and in the future through reasonable and appropriate regulation of these existing and emerging contaminants.
