ADDENDUM #1 TO REQUEST FOR BID Wheel Loader

In reference to the Town of Merrimack's Request for Bid for one wheel handler loader for the Wastewater Treatment Facility, due on Monday, October 2, 2023 at 2:00PM, please be advised that the following wording has been changed in our specifications:

Wording in removed:

15. <u>Machine Availability Guarantee</u>: In the event of a warrantable failure, the bidder shall guarantee to repair the machine to an operating condition within 72 hours from the time of arrival at the bidder's location. If the bidder cannot comply with this clause, a comparable machine will be provided at no cost, except transportation, until the repairs are completed. If no comparable machine is available by the bidder a daily rental credit payment of \$300.00 will accrue until repairs are completed. Details of this warranty shall accompany the bid.

Revised paragraph:

15. <u>Machine Availability Guarantee</u>: In the event of a warrantable failure, the bidder shall guarantee to repair the machine to an operating condition within 72 hours from the time of arrival at the bidder's location. If the bidder cannot comply with this clause, a comparable machine will be provided at no cost, except transportation, until the repairs are completed

Wording removed:

16. Parts Availability Guarantee: If purchaser orders a new part necessary to operate the machine and bidder does not have the part available or give reasonable notice the part is available for pick-up at the store from which ordered within 72 hours, the bidder shall, upon request, furnish the part at no cost. Parts covered by this guarantee must be ordered from the bidder's parts department during normal working hours. This guarantee will not apply when parts are ordered by bidder in connection with service work in progress. Details of this guarantee shall accompany the bid.

Revised paragraph:

16. Parts Availability Guarantee: If purchaser orders a new part necessary to operate the machine and bidder does not have the part available or give reasonable notice the part is available for pick-up at the store from which ordered within 72 hours, the bidder shall, notify us of the estimated time of delivery if longer than 10 business days. If the bidder cannot comply with this clause, a comparable machine will be provided at no cost, except transportation, until the repairs are completed. Parts covered by this guarantee must be ordered from the bidder's parts department during normal working hours. This guarantee will not apply when parts are ordered by bidder in connection with service work in progress. Details of this guarantee shall accompany the bid.

Paragraph #20 has been completely removed from specifications:

20. Repurchase Guarantee: Guarantee as to the minimum price which the bidder agrees to repurchase the machine from the purchaser after five years or 7,500 hours, whichever occurs first. Machine is to be in good operating condition and serviced according to manufacturer's specifications.
