REQUEST FOR BID COPY PAPER

Faxed bids will be received by the Town of Merrimack *until 2:00 PM on Friday, August 25, 2023* to supply and deliver 65 cases of copy paper to the Town of Merrimack in accordance with the following detailed bid specifications and conditions:

The bid shall be submitted on the Bid Form furnished herewith and shall exclude state and federal taxes not applicable to municipalities. The copy paper shall be:

- 8.5 x 11
- 20 lb
- 92 brightness
- For use in toner-based copiers and printers
- 10 reams per case
- 500 sheets per ream

The brand of copy paper shall be noted on the bid form. Multiple bids are accepted; please use a separate bid form for each bid.

The paper shall be delivered to three offices, as indicated:

- Twenty (19) cases shall be delivered to the Finance Department, 8 Baboosic Lake Rd, Merrimack, NH. There is a ramp entrance, or a door with three steps.
- Fifteen (10) cases shall be delivered to the Town Manager's Office, 6 Baboosic Lake Rd, Merrimack, NH. This office uses the same ramp entrance.
- Ten (10) cases shall be delivered to the Tax Collector's Office, 6 Baboosic Lake Rd, Merrimack, NH. This office uses the same ramp entrance.
- Eight (8) cases will be delivered to the Public Works and Community Development Departments, 6 Baboosic Lake Rd., Merrimack, NH (lower level, no steps)
- Four (2) cases shall be delivered to the Highway Department, 76 Turkey Hill Rd, Merrimack, NH.
- Twenty (10) cases shall be delivered to the Police Department, 31 Baboosic Lake Rd, Merrimack, NH. There are no stairs at this location.
- Six (6) cases shall be delivered to the Waste Water Treatment Facility, 36 Mast Rd, Merrimack, NH.

The bid price shall include delivery and be quoted F.O.B. Town of Merrimack offices at 6 & 8 Baboosic Lake Rd, Police Department, 31 Baboosic Lake Rd, Highway Department at 76 Turkey Hill Rd, and Wastewater Treatment Facility, 36 Mast Rd, Merrimack, NH. The time required for delivery must be indicated on the Bid Form and be guaranteed.

The Town reserves the right to reject any or all bids, to waive irregularities in the bids, and to accept the bid which best serves the interest of the Town.

Bids must be faxed to the Town of Merrimack Finance Department at (603) 424-0516 by the date and time specified above. It is the bidder's responsibility to confirm the bid is received by the Finance Department by the date and time specified.
