REQUEST FOR BID EV Fire Blanket

Sealed bids will be received by the Town of Merrimack until 2:00PM on Tuesday, May 7, 2024 to supply one (1) EV Fire Blanket to the Town of Merrimack's Fire Department in accordance with the following specifications and conditions:

- Standard size – 20'x 26' – approx. 105 lbs
- Rated for temperatures over 1832°F (1000°C) and pack ratings over 50kWh
- Handles at each corner and sides allow for ease of deployment by two or more responders
- Color in red or blue

TESTING:

- 30 Minute Powerplant Fire Penetration Test
- 14 CFR, Part 25 D §25.853
- 60 Second Vertical Burn Test
- 5 Minute Cargo Liner Burn Test

The bid shall be submitted on the Bid Form furnished herewith and shall exclude state and federal taxes not applicable to municipalities. The bid price shall be quoted F.O.B. Merrimack Fire and Rescue, 432 Daniel Webster Hwy, Merrimack, NH.

The Town reserves the right to reject any or all bids, to waive irregularities in the bids, and to accept the bid which best serves the interest of the Town.

Bids must be marked "Bid for EV Fire Blanket" and shall be faxed to the Town of Merrimack Finance Department at (603) 424-0516 or mailed to the Finance Department located at 6 Baboosic Lake Rd, Merrimack, NH by the date and time specified above.
