Each vendor must include a product specification sheet for their specified product in the bid packet. A certification letter must also be included that guarantees that the product shall meet the minimum specifications listed on the product specification sheet for said product throughout the entire contract period.

The proposal must be filled out and signed as directed herein, sealed in an envelope addressed to the, Town of Merrimack Finance Department, Merrimack New Hampshire, endorsed with the name and address of the Bidder and "Proposal for Polymer- Delivered" and submitted to the Town of Merrimack-Finance Department, 6 Baboosic Lake Rd., Merrimack, NH 03054, before 2:00 p.m. local time on Friday, May 10, 2024 addressed to Kelly Valluzzi, Purchasing Agent.

Proposal submitted as above directed and no other will at the above named hour and place (Finance Department, 6 Baboosic Lake Rd, Merrimack, New Hampshire) be publicly opened and read aloud. The Town of Merrimack reserves the right to waive any informality in or to reject any and all bids, or to accept any bid which it deems advantageous.

No bidder may withdraw his or her bid within (15) days after the opening date.

### **BID AWARD BASIS.**

All companies invited to bid for RDT polymer delivered have all bench tested and run at least 1 successful trial with the specified products at the facility within the last year. Through previous trials and bench testing, all polymers we have requested bids on have been determined to be suitable for the facility's needs. The lowest price per pound shall determine the bid award winner.

Announcement and notification of the winning bidder shall be completed no later than June 30, 2024.

# AS PART OF THE CONTRACT AGREEMENT, WE WILL EXPECT THE FOLLOWING CONDITIONS BE MET:

- Bid Price shall be firm for (1) year and include all costs, including cost of fuel to deliver said Polymer and any return or handling charges for totes. No fuel surcharge will be allowed.
  - 2. Delivery must be made within 5 business days from the time order is placed.
  - 3. Deliveries must be made between the hours of 7:00 a.m. and 1:00 p.m. Monday through Friday.
  - 4. Each delivery shall be accompanied by a Certificate of Analysis for that particular lot
  - 5. Deliveries shall be made in 275 gal totes.
  - 6. A one-tote minimum shall apply.
  - 7. Product quality is to remain consistent through the contract period.

If any of the above conditions are not met, it shall be cause for a breach of contract, which would then null and void said contract.

The Town of Merrimack under this agreement will reserve the right to go out to bid in less than one year should the polymer provided under this contract lose its effectiveness and or not produce the anticipated results for capture and performance. Notice shall be provided in writing (30) days prior to going out to bid.

The contract period will be from July 1, 2024 to June 30, 2025. The price is to be firm for entire contract period.
