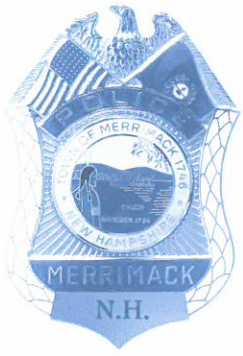

- Acquiring skills to resist peer pressure.

- Enhancing self-esteem
- Learning about alternatives to substance abuse
- Learning anger management and conflict resolution skills
- Developing risk-assessment and conflict evaluation
- Reduce violence
- Build interpersonal and communication skills
- Resist gang involvement and behavior
- Strong attention to alcohol/tobacco resistance technique for minors.
