**Hall Roof Slates**; Ralph has made a larger version of the town seal stickers. Has located a craftsman who will mount them on the slates and decoupage them. Suggestion made to donate one to Historical Society speakers.

**Upham Road development**: No further information. Documents seen at meeting with plans for development. Titled: Hazen Property. Lots 4-B-114- and 114.2. Anita has left a note for staff to consider protection of site of Fuller's Mill. Chip will plan a field trip to the site when the weather allows.

**Old King's Highway**:

Field trips planned on April 23 or 24 to also include Ruth Marcel. See new business below.

**Thornton's Ferry/ Sklar Park**: We will be involved with subcommittee to make plans. Anita will locate railroad plans, showing location of Lutwyche/Thornton home. Consider possible scans for past building locations and archeological digs.

**NEW BUSINESS**:

**Annual report** Anita submitted. Will give formal report to the Town Council on March 15.

**Request donation from winner of lottery**: Anita will write to the lawyers for the Trust set up by the lottery winner, asking for consideration of major donation to the heritage Commission and Historical Society for purchase and/or preservation of historical sites. Some suggested sites could include Rev. Wright's home, the Hazeltine/Gordon home, the French/Farr home, the Currier Orchard property, the Old King's Highway, the old Fish Hatchery and other historical sites as may become available.

Chip will research the deed to the Wright property, now owned by the Manchester, YMCA.

**Contact list**: Anita to develop a contact list for Commission Members.

**Symond's Rock Preservation**: Documents seen at meeting for plans to subdivide lots 2D-4 between Manchester Street and Al Paul Lane. Anita has left note for staff to consider the status of Symond's Rock, which is listed on the NH List of Historical Places. Does not appear found on the maps or documents.

**OPEN COMMENT**: Chip presented some ideas for future projects:

**Class 6 roads**: Merrimack has three: Grater Road, Old King's Highway and Old Blood Road. Clearing, maintaining and proper signage for original locations. Will require coordination with Conservation Commission, since much of this is in their domain. Try to locate plans made in past for OKH signs and create some for other two roads.

**Village Signs**: Now that we have North and South town welcome signs, look toward four Village signs to coordinate with brochures. Chip will research similar signs in other towns.

**Schoolhouse Site Signs**: Create signs for original schoolhouse locations.
