The Town Council will hold a public hearing to accept and authorize the expenditure of up to \$6,800 of the grant from NHDES for milfoil control via Diver Assisted Suction Harvesting (DASH), in addition to the Town's matching share of \$10,200 this fiscal year for DASH for variable milfoil control efforts in portions of Horseshoe Pond and Naticook Lake. This totals \$17,000. We ask that the Town's share be expended from the Milfoil Capital Reserve Fund, pursuant to RSA 31:95-b and Charter Article 8-15.
